ORDER

As per the Government Order read as 1st paper above, Government had approved a scheme for providing Puese Building Grant to Ex-Servicemen. The House Building Grant was further enhanced as per Government Order 3rd and 4th paper read above

As per the existing norms of the scheme of House Building Grant to the Ex-Servicemen, cannot cover more beneficiaries mainly due to the ceiling of income limit. The major portion of the fund allocation remains unspent every year. Hence the Director of Sainik Weifare has forwarded a proposal regarding the extension of House Building Grant for more categories of beneficiales and also the enhancement of the present income limit of House Building Grant.

Government have examined the matter in detail and are pleased to extend the following norms for granting House Building Grant to Ex- Servicemen.

a. The existing income limit for all categories of Ex- Servicemen/War Widows/ War disabled is enhanced from Rs.50.000 (Rupees Fifty Thousand only) to Rupees 1.50 lakhs (Rupees One lakh and fifty thousand only).

- b. The amount of grant is enhanced from Rs.70,000/- (Rupses Seventy Thousands only) to Rs.100,000/-(Rupees One Lakh only).
- c. Priority should be given to those applicants with higher age (below the age of 60 years), lengthier service and lower income.
- d. The last date for submitting application for the Ex- Servicemen category, before the Director of Sainik Welfare, is 31st August every year.
- e. The Time limit for submitting application for House Building Grant is extended to 5 years instead of the existing 3 years.

The existing Government Order is modified to the above extent.
