ORDER

In the G.O. read Government have issued a consolidated order for the "Scheme of award of scholarship to bright students among the children of Ex-servicemen" in supersession of all orders issued in the matter. In the letters read above the Director of Sainik Welfare has proposed certain amendments to the scheme.

After having examined the matter the following amendments are ordered.

Para 3 (i) of Annexure I will be amended as:

For the following courses under the Director of Technical Education, the Director of Sainik Welfare shall sanction scholarship to one student per course for the entire state having the best academic performance based on their record in the previous year - Final examination from the children of Ex-Servicemen in that course.

Para 9 of Annexure I will be amended as:

As and when the scholarship sanctioned to the students, the Director of Sainik Welfare will make "Allotment order for sanctioned amount on TR-109" by debiting to the appropriate Head of Account and forward to the Zila Sainik Welfare Officer concerned who will be responsible for drawing the money on TR-42 and disburse after getting a stamped receipt for the amount from the father/widowed mother or guardian (in case both the parents of the student are not alive) and the fact intimated to the Head of the Institution where the student is studying".
