## **ORDER**

As per the Government Order read as 1st paper above, Government have approved a scheme for award of scholarships to bright students among children of ex-servicemen. As per the above scheme as amended from time to time the students attending regular classes in various educational institutions are eligible for the scholarship. The Director, Department of Sainik Welfare in his letter read above has forwarded proposals to liberalise the scheme by extending it to few more courses of studies and by bringing the students of Mahatma Gandhi University also under the purview of the scheme. He has also forwarded proposals to enhance the income limit of parents and the amount of scholarship.

- Government have examined the matter in detail and are pleased to approve the proposal
  of the Director, Department of Sainik Welfare and to issue consolidated orders as in the appended
  scheme in supersession of all Government Orders issued in the matter.
- The expenditure on the scheme will be debited to the provision under the head of account '2235-60-200-94-Financial assistance for children of ex-servicemen'.
- 4. The Price for each printed form of application is fixed as Rs. 2. The Director, Department of Sainik Welfare will arrange for printing the required number of application forms through the Government Press for distribution.
- The Director, Department of Sainik Welfare will take necessary steps for disbursement of the scholarships before the close of every financial year.
