## ORDER

In the letter 9th read above, the Director of Sainik Welfare reported that in the meeting held on 04/12/96 of the Rajya Sainik Board, It was recommended to introduce 'Cash Grant' under the remaining three Gallantry Awards and also to introduce 'Cash in lieu of land' and Annuity under the eleven Gallantry awards.

- 2. The Adjutant General and Chairman PPOC, Army Head Quarters, New Delhi as per his letter read as 10<sup>th</sup> paper above has also requested for granting of Cash awards, Cash in lieu of land and Annuity to the Gallantry Award Winners.
- 3. Government have examined the proposals in detail and are pleased to sanctions the following monetary allowances and they order accordingly:-
- (a) The Defence personnel belonging to Kerala will be granted Cash Grant under the 3 remaining Gallantry Awards in the following rates:-

(b) The Defence personnel belonging to Kerala Will be granted 'Cash in lieu of land' and 'Annuity' under the eleven Gallantry Awards in the rates shown below:
