ORDER

In the G. Os. read as 1st and 4th papers above, Government had issued orders sanctioning immediate grant of Rs. 5,000 (Rupees five thousand only) in cash to the dependent of Defence personnel killed in action and ex-gratia grants varying from Rs. 1,000 to Rs. 5,000 to disabled and wounded service personnel during the Chinese aggression 1962 and Indo-Pak Conflicts, 1965 and 1971 depending on the degree of disability of the individual. In the G. O. read as 5th paper above, sanction was accorded for extension of these benefits to the dependents of Jawans killed/defence service personnel wounded in the operation 'Blue Star' in Punjab in June, 1984.

Government of India have now requested the State Government to extend Co-operation and help in the task of resettlement and welfare of the Indian Peace Keeping Force Personnel disabled/wounded in Sri Lanka and the families of those personnel killed in action. Accordingly, the Director, Department of Sainik Welfare, in his letter read above, has forwarded proposals to extend the benefit of immediate grant and ex-gratia payment sanctioned in the G. Os. read as 1st and 4th papers above to the Defence Personnel of the Indian Peace Keeping Force killed/wounded in Sri Lanka also.

3. Government have examined the matter in detail and are pleased to accord sanction for payment of immediate grant of Rs. 5,000 (Rupees five thousand only) in cash to the dependent (wife, children, father or mother) of Defence Personnel of Indian Peace Keeping Force belonging to Kerala killed in action in Sri Lanka. Sanction is also accorded for payment of ex-gratia grant to the defence personnel of the Indian Peace Keeping Force belonging to Kerala who were wounded in action in Sri Lanka at the rates fixed in G. O. (Ms.) 435/71/PD dated 13-12-1971 and G.O. (Ms.) 380/77/GAD dated 13-11-1977.

The expenditure on this account will be incurred by following "New Service Procedure."
