ORDER

In the Government Order read as 1st paper above, Government have fixed eligibility criteria of mark system for selecting beneficiaries to grant Financial Assistance from State Military Benevolent Fund/ District Military Benevolent. Fund. Financial Assistance mentioned in Rule 7 (c) (i) and 8(a) from SMBF/DMBF has been amended by substituting the amount as ₹ 3000, ₹ 3500, ₹ 4000 and ₹ 2000, ₹ 2500 respectively as per Government Order read as 2nd above.

In his letter read as 3rd paper above, the Director of Sainik Welfare has requested to amend the eligibility criteria of mark system for selecting the beneficiaries to grant Financial Assistance from SMBF/DMBF as per Rule 7 (c) (i) and 8 (a).

Government, after having examined the matter in detail are pleased to amend the eligibility criteria of mark system as follows, for granting Financial Assistance as mentioned in Rule 7(c) (i) and Rule 8(a) from SMBF/DMBF in the Government Order read as 2nd above, in lieu of Annexure A of Government Order read as Ist above.
